As the first step in our Curriculum Resources Plan, we are implementing K-12 ELA and Math programs that have a strong digital component and provides a structure, questions, and approaches that support OLS and NGA (AIR State Tests). We are piloting Science and Health this year with adoption for next year. We have also implemented MAP, Compass Learning, Fast Forword, Myon, and ThinkCerca.

Alternative School
Alternative School-1 student graduated last year. There are currently 5 students in class. Four students have transitioned back to the JH/HS last year.



Ohio Graduation Testing (OGT) and End of Course (EOC) intervention groups



Revaluate special education needs for students having trouble passing OGT/EOC Intervention is provided to Seniors for OGT still needing to take the test. We still have 20 students needing to take 44 tests.

EOC-Students who did not get a Passing score of 3 on the Spring of 2016 tests will retake the test in December of 2016, Students will receive intervention prior to testing.

OBJECTIVE 1: Enhance Community Communication



> To communicate with 100% of the residents at least quarterly and have at least 20 other specific contacts with the public

All residents of FCSD receive a district quarterly newsletter. Through plays, musicals, along with choral and music concerts, there were more than 20 performances for the community. School marquees are changed monthly with the exception of summer break. 120 articles were submitted to the Middletown Journal and Franklin Chronicle. There were 8 presentations to the Chamber of Commerce and 3 presentations to the Rotary Club.

Action Steps to meet Objective 1:

- Change school marguees at least monthly
- Submit 92 articles to the Middletown Journal and the Franklin Chronicle, as well as place such items on our district webpage and Facebook page
- Spotlight at the Chamber meeting on "What's new in the Franklin City Schools" at least six times a year
- Rotary presentation about school events at least twice a year
- Provide the community with a state of the district address semi-annually and have it for public consumption on the website and channel 18
- District newsletter will be sent quarterly to all residents of the district

OBJECTIVE 2: Volunteers in Schools and/or community



➤ Increase the number of volunteers by 10% from 1,109 to 1,219 hours for the 2015-2016 school year

We have over 1,219 volunteer hours for the 15-16 school year. We advertised volunteer hours on our district website and Facebook page. Principals also advertised volunteer opportunities at various school activities. Specifically, they advertised at Open House and Meet the Teacher nights. A new objective was established to maintain at least 1,200 each school year.

Action Steps to meet Objective 2:

- Advertise volunteer opportunities on our district website and Facebook page
- Provide a list of volunteer opportunities at each open house/meet the teacher event in the schools and actively ask for help
- Select a "volunteer of the month" and acknowledge through media (website, Facebook, news article, board recognition) and give a \$250 scholarship from the student achievement committee to the program of choice of the recipient Quarterly "Good Neighbor" award

OBJECTIVE 3: Annual Community Outreach Event



➤ Increase the number of community events from 28 to 31

There were 37 community outreach events during the 16-17 school year. The Franklin High School chorus performed at the December Chamber meeting and Fundraiser along with such performances at the Rotary Club, Warren County Retired Teachers Club, AK Steel Retired Steel members meeting, Franklin United Methodist Church Mother/Daughter Banquet, Franklin Ridge Retirement Home, and the Franklin Township Christmas Festival. The Hunter PTO had a Community Clean-Up Day. Gerke students read to residents of the Sherman Glenn Retirement House. Anthony Wayne held a Community Luncheon. Franklin High School Choir performed a holiday concert at Spring Hill. Schenck held a neighborhood cleanup for Earth Day. Schenck also held their fall fest and the Girls on the Run Food Drive for the Franklin Pantry. Christmas gifts were collected from all Franklin City Schools for needy students as organized by school counselors. The district also had a table at the Chamber Mix-Po held at Strike Zone.

OBJECTIVE 3: Maintain Positive Cash Balance with NO NEW MONEY LEVIES TO 2024

➤ Maintain District Financial Stability without asking taxpayers for additional property taxes



The District has two Emergency Levies (Expiring 12/31/19 & 12/31/20). The Board expects to request approval of a Substitute Levy (November 2018) at the same exact dollar amount as the emergency levies - (NO INCREASE IN TAXES). The Substitute levy will allow the taxpayers to continue to receive rollback credits on their homes on the emergency levy originally approved in 2005.

Action Steps to meet Objective 3:

- Continue 5-year building and departmental budgeting process
- Continue to provide administrators and Board of education with details of the budget for 5-year period and Keep administrators and Board of Education informed of the financial information and how decisions affect the forecast, especially when a decision may cause deficit spending



OBJECTIVE 1: Technology to Student Ratio



> Purchase only user friendly technology having the ability to be immediately used by students

The District has invested more than \$600,000 in infrastructure upgrades. For the 2016-17 school year, the district spent over \$225,000 in purchasing 570 Chromebooks for students in grades 1-12. Each of the five elementary schools received one cart with 30 Chromebooks along with four bins that each contained six Chromebooks each. The high school also received a cart of 30 Chromebooks and the student 1:1 device initiative began where all 7th grade students and 1 cohort of 22 freshmen received a Chromebook for their personal use. For the 2017-18 school year, all students in grades 7-9 will have individual Chromebooks at their disposal. The 1:1 device initiative rollout was developed by the FCSD Core Tech Committee.

Action Steps to meet Objective 1:

- Only purchase technology, as needed for specific purpose which will make a difference in the education of each student using the technology
- Have technology plan developed prior to any purchase: infrastructure prior to device purchase

OBJECTIVE 2: Safety – Security Improvements to facility entrances

➤ Make improvements to increase facility safety



The District secured grant money to put MARCS systems in every building where there are students. The MARCS system allows administration to call police with the touch of a button. It will notify local police and they can respond to the emergency situation. This button is only used in extreme security situations. Security cameras have been installed in and around Franklin High School, Franklin Junior High School, and Anthony Wayne Elementary. Cameras will be added in the summer of 2017 in and around Pennyroyal Elementary and the Franklin City Schools Stadium. Safety vestibules have been installed at Hampton Bennett, Franklin High School, Franklin Junior High School, and Schenck Elementary. In the summer of 2017, one will also be added to Anthony Wayne Elementary. Safety vestibules and security cameras will be added to an additional school in subsequent years until all of the facilities have been updated. The Navigate Security System has been added district-wide and all safety plans have been approved by the State of Ohio.

Action Steps to meet Objective 2:

- Utilize MARCS grants for emergency communications
- Apply for security grants for increased building safety renovations

- Utilize bus routing system to prolong the useful life of each bus (changing routes from long to short route, etc.)
- Hire more substitute drivers

The VersaTran System is used to develop bus routes. Each bus is rotated between a high-mileage and a low-mileage route every two years.
